I understand that East Site Inc. will have no liability regarding the adequacy of any evacuation plan, medical care, equipment or supplies that may be provided. I agree to be responsible for my own and accept any and all risks of delay, unanticipated events, illness, injury, emotional trauma and death.

Responsibility:

I understand that the responsibility of East Site Inc. is strictly limited. As a United States of America based travel company, East Site Inc. promotes, and sells tour programs and trips consisting of certain travel services, including but not limited to surface transportation, excursions, and accommodations which East Site Inc. purchases or reserves from various suppliers on my behalf.
